## Did You Know?

### Donation of Publicly-Traded Securities & Mutual Funds

Canada's 2006 Federal Budget introduced a special tax incentive on gifts of Publicly Traded Securities and Mutual Funds. You can give a gift of publicly traded securities to March of Dimes and eliminate the capital gains tax which is usually 50% of the capital gain. By donating them directly to March of Dimes you can reduce your tax bill and make a significant gift at the same time.

A donation receipt is issued for the fair market value of the security on the date of transfer. The gift will not qualify for the capital gains tax elimination if the securities are sold and the cash then gifted to a charity.

If you are thinking about transferring assets that have appreciated in value, you should seek expert advice from a tax specialist or your broker. We strongly recommend that you seek professional advice to ensure your financial goals are considered, your tax situation reviewed, and that your gift is tailored to your circumstances.
